You are requested to comply with the provision of contract labor (Regulation and abolition) Act of 1970 and contract labor (Regulation and Abolition) central rules 1971 child labour (Prohibition & Regulation) Act 1986,construction workers (Regulation of Employment and Condition of Service) Act 1996, Building and other Construction workers welfare cess Act 1996 as specified in Clause -19 on page no. 49 of GCC of Tender and rules of Central and state Government and minimum wages Act and rules thereof of Central and State Government.
4. You are requested to get yourself Registered with Service tax collection authorities, if applicable and submit the documentary evidence to Engineer-in-Charge within 30 days of issue of award letter.
5. You are also directed to contact AGM (Engg-C), AAI, Dimapur Airport, immediately who will arrange to hand over the site to you.
6. Please note that the time allowed for carrying out the work is as entered in the tender is **02(Two) months** which shall be reckoned from the 10th day after the date of issue of this letter.
