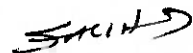

1. Your e-tender for the work mentioned above is hereby accepted on behalf of Chairman, Airports Authority of India vide LOI dated 22.04.2022 at the item rates quoted by you totaling to Rs. 30,40,37,997/- (Rupees Thirty Crore Forty Lakhs Thirty Seven Thousand Nine Hundred and Ninety Seven Only) (excluding GST) which is 21.05% below the estimated cost put to tender of Rs. 38.51 Cr. (Rupees Thirty Eight Crore Fifty One Lakhs Only) (excluding GST);
2. You are requested to attend the office of the Jt. GM, Engg (C), AAI, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi by 21.06.2022 to sign and complete the Contract Agreement. The contract agreement shall be executed on a non-judicial stamp paper of value of Rs. 100/- (Rupees One Hundred Only) and the cost of the stamp paper shall be borne by you. Jt. GM Engg (Project), AAI, Gwalior Airport shall be the Engineer-in-charge of the work.

3. You had been exempted for deposition of EMD for the subject tender. Therefore, you are requested to deposit Rs. 1,52,01,900/- (Rupees One Crore Fifty Two Lakhs One Thousand and Nine Hundred Only) towards Security Deposit within 10 days from the date of issue of this letter failing which, the same will be deducted as per condition Clause -1(A) on page no. GCC- 16 of the tender document.
4. You were requested to submit to AAI, a performance Guarantee as per condition of clause 1 on Page GCC-15 of Tender Document and Schedule-E on Page GCC-130 for an amount of Rs. 91,21,140/- (Rupees Ninety One Lakhs Twenty One Thousand One Hundred and Forty Only) in the form of Bank Guarantee from a Nationalized/Scheduled Indian bank but not from any Co-operative or Gramin Bank in the proforma appended in the tender document.
5. You are requested to comply with the provision of contract labour (Regulation & abolition) Act of 1970 and contract labour (Regulation & Abolition) Central Rules 1971, Child Labour (Prohibition & Regulation) Act 1986, Construction workers (Regulation of Employment and Conditions of Service) Act 1996, Building and other Construction workers Welfare Cess Act 1996, Minimum Wages Act 1948, Employees Provident Fund & Misc. Provisions Act 1952 and ESI Act 1948, amended from time to time and rules thereof Central and State Governments.
6. You are also directed to contact Jt. GM Engg. (Project), AAI, Gwalior Airport immediately who will arrange to hand over the site to you.
