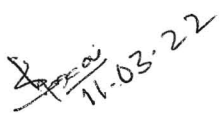
Note: The Tender was published on 13.12.2021 date of opening was 04.01.2022. It was observed that Two (02) bidders participated in the Bid process, M/s S. Caterers, Bid ID: 367887 & M/s Arvind Enterprises, Bid ID: 361675. M/s Arvind Enterprises didn't submit any Cost of TD / EMD and they submitted blank document / NIT. The bid submitted by M/s Arvind Enterprises was not admitted. Only single eligible Technical bid of M/s S. Caterers, Patna was admitted as they submitted cost of TD & EMD as confirmed from Finance Section. Therefore, Corrigendum-1 extending date by 15 days was published on 04.01.2022. The Technical Bid was opened on 20.01.2022 and on scrutiny by the committee it was observed that the M/s S. Caterers didn't submit the requisite documents fulfilling conditions that the parties have operated more than Three outlets in the One year period, during last Five years in Airports, out of which at least One is in the Airport which handled more than 01 Million Passengers as on the date of publication of Tender fulfilling conditions as per NIT Clause 10) A (ii). Bidder didn't submit No Dues Certificate for the period upto 30.09.2021 from all AAI Airports as per NIT Clause 3 (f) of General Information and Guidelines. Therefore the party was asked to submit the shortfall documents in the shortfall document in E-tender portal. The party didn't submitted the Shortfall documents in CPP Portal. The committee recommends that the Technical Bid submitted by M/s S. Caterers, Patna is not Technically qualified. Therefore, it is recommended the Tender process may be cancelled.
