You are requested to comply with the provision of contract labour (Regulation & Abolition) Act of 1970 and contract labour (Regulation & Abolition) Central Rules 1971, Child Labour (Prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and Condition of Service) Act 1996, Building and other construction workers Welfare CESS Act 1996 as specified in GCC of Tender and rule of Central and State Government.
5. You are also directed to contact Senior Manager (E-C), AAI, RVST Airport, Gwalior, immediately who will arrange to hand over the site to you.

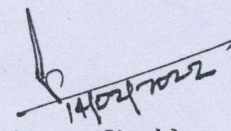
