4. You are requested to comply with the provisions of Contract Labour (Regulation and Abolition) Act 1970 and Contract Labour (Regulation and Abolition) Central rules 1971 Child Labour (Prohibition & Regulation) Act 1986, Construction workers (Regulation of Employment and Condition of Services) Act 1996, Building and other Construction Workers Welfare Cess Act 1996 as specified in Clause 19 of GCC of tender and rules thereof Central and State Government.
5. You are also directed to contact Asst. General Manager (E-C), AAI, Puducherry Airport, Puducherry immediately who will arrange to hand over the site to you.
