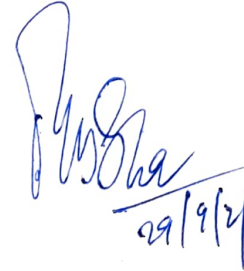

To register on the portal follow these steps
