5. Payment will be made on the request of the contractor.
6. No price variation and no advances are admissible for this contract.
7. The contractor shall adhere to guidelines of DPCC to curtail pollution and follow all the statutory laws issued by Govt. of Delhi.
8. You shall ensure full compliance with Tax Laws of India with regard to this work and shall be solely responsible for the same. You shall keep the employer fully indemnified against your liability of tax, interest, penalty etc. in respect thereof, which may arise.

10. All the work shall be executed in accordance with the specifications stipulated in Tender & as per BOQ enclosed herewith.
11. It may please be noted that this letter and all types of terms & conditions mentioned in the Tender Document will be binding between you and DMRC till formal Agreement is executed.
12. You are required to maintain insurance policy preferably in the name of DMRC.
13. The Performance Security required in accordance with Clause no.3 of the SCC shall be for **3% of contract value**. The Performance Security shall be furnished to the Employer within 30 (thirty) days from the date of issue of the Letter of Acceptance. If it is submitted in the form of BG then it should be confirmed through SFMS platform.
