

Recommendation of TEC after shortfall on technical bid for the work of e-tender No IWAI/KOL/8/NN/2021-22 for Installation, operation and maintenance of 24 hrs navigational aids between Kolkata-Rajmahal stretch of NW-1 (River Ganga) during October 2021 to March 2022 which was opened on 07.09.2021.

1. The e-tender were invited in two cover system through on line (cover-1: technical bid and cover-2: financial bid) by IWAI Kolkata vide e-tender no IWAI/KOL/8/NN/2021-22 for Installation, operation and maintenance of 24 hrs navigational aids between Kolkata-Rajmahal stretch of NW-1 (River Ganga) during October 2021 to March 2022. The above NIT was published in Bengali, Hindi and English newspaper and also uploaded on IWAI's web site & CPP portal for giving wide publicity. As per the NIT, the tender documents were to be submitted online by the bidders to Director, IWAI, Kolkata on or before 24.08.2021 upto 15.00 hrs. Technical bids were opened on 25.08.2021 at 15.30 hrs.
2. The following bidders have submitted their e-bids along with required documents mentioned in tender:

 - 2) MRS. Ranu Nandi, Senpara P.O.-Bidyaparan-783324, Dist.-Dhubri, State:- Assam
3. The statement of documents and the bids submitted is enclosed at Annex-2
4. Technical Evaluation Committee consists of (i) Director; (ii) A.D(Civil); (iii) J.A.O and Shri Anand, Civil Engineer, Arth Ganga nominated to assist the committee.
5. a) M/s Rama Shankar Prasad, 1st Floor, Block-B, B1W, Ashirbad Villa, Jaymati Nagar, Main Road, Pandu, Guwahati- 781012 (Assam) have submitted all required documents to fulfill all technical parameters mentioned in the tender documents except valid survey certificate of the mechanized vessel/boat owned.
6. b) MRS. Ranu Nandi, Senpara P.O.-Bidyaparan-783324, Dist.-Dhubri, State:- Assam have submitted all required documents to fulfill all technical parameters mentioned in the tender documents except valid survey certificate of the mechanized vessel/boat owned.
7. Hence, considering above, TEC recommends to ask shortfall in online i.e valid survey certificate of the mechanized vessel/boat owned of M/s Rama Shankar Prasad and Mrs. Ranu Nandi which shall be submitted upto 07/09/2021 upto 15.00hrs. After submission of the shortfall documents then the TEC will finalize the recommendation of technical bids.
8. After, opening of the shortfall document on 07/09/2021, it is observed by the TEC that M/s Rama Shankar Prasad and Mrs. Ranu Nandi have submitted valid survey certificate of the of mechanized vessel/boat owned as asked in the shortfall in online from both above mentioned bidders. Hence, considering above, TEC recommends to M/s Rama Shankar Prasad and Mrs. Ranu Nandi as technically qualified bidders for this tender and also TEC recommends to open the financial bids of both qualified bidders on 07.09.2021.
