(a) M/s Dolphin Security & Advertising, Guwahati.

M/s Dolphin Security & Advertising has submitted the relevant documents in support of their MSME registration, average turnover, partnership deed, solvency certificate, experience in similar works etc. The firm may be technically qualified.

(b) M/s Subir Paul Chowdhury, Kolkata

M/s Subir Paul Chowdhury, has submitted the relevant documents in support of their MSME registration, average turnover, solvency certificate, experience in similar works etc. except Power of Attorney as per Section IV -4D, 4F, trade license.

In reference vide letter No.IWAI/GHY/Manning, O&M/4(129)/2021-22/503 dated 06.11.2021 was issued to firm for submit the Power of Attorney as per Section IV form -4D, 4F and Trade License of the firm. In this regard, confirming regarding Power of Attorney as per section IV form-4D, 4F, trade license has been received through email dated **08.11.2021**. Hence, the firm may be technically qualified.

(c) M/s Galleon Shipping Ltd., Kolkata

M/s Galleon Shipping Ltd. has submitted the relevant documents in support of their MSME registration, average turnover, solvency certificate, experience in similar works etc. The firm may be technically qualified.

(d) M/s Libraa Ship Management Pvt. Ltd., Chennai

M/s Libraa Ship Management Pvt. Ltd. has submitted the relevant documents in support of their MSME registration; average turnover; experience in similar works etc. except signed tender documents in E-procure website, Annual/Report/ Audited balance sheet, Integrity Agreement, Labour License as per tender procedure. In reference vide letter No.IWAI/GHY/Manning, O&M/4(129)/2021-22/502 dated 06.11.2021 was issued to firm for submit the discrepancy documents before 11.11.2021. Till date, firm has not submitted the required documents .Hence, the firm is technically not qualified.

Recommendation:

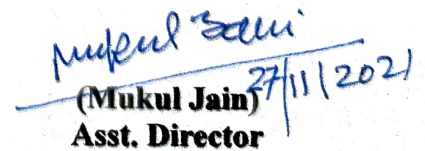
