**The following are observed by TEC:**

M/s Luit Construction, Guwahati (Assam) and M/s Rama Shankar Prasad, Guwahati (Assam) have submitted/uploaded the requisite documents as per tender conditions. These 2 (two) bidders may be qualified in technical bids. M/s Rongmonee Enterprise, Dibrugarh (Assam) may not be considered technically qualified in technical bid as they have not submitted/uploaded requisite documents as per tender conditions. For Jogighopa, there is single bid and for Pandu, Uzanbazarn Silghat, Biswanatghat, Neamati, & Oriumghat terminal where there is two bids for each terminal received. For Bogibeel terminal three bids received in which two bidders technically qualified.

**Recommendation:**

TEC opined that technical bids of M/s Luit Construction and M/s Rama Shankar Prasad, Guwahati (Assam) have qualified in the event and their price bids may be opened.
