- (iv) An amount of Rs. 2,29,598/- shall be deposited towards Performance Guarantee through RTGS in the following bank particulars and submit the proof along with UTR No. at the time of concluding Contract Agreement.

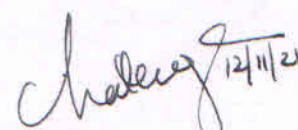
