Ernakulam & (iv) Shrinath Chathrabettu, Beejadi Village, Koteswar Post, Kundapur participated in the tender. The bidders Sl. No. (i) & (iii) & (iv) have submitted all the required documents as per checklist and hence, technically qualified. The bidder as per Sl. No. (ii) has not furnished relevant Experience certificate, valid Registration certificate and solvency certificate even after allotting extra time for submission of the same. Hence, the bidder Sl. No. (ii) is technically not qualified. Therefore, the TEC recommends to open the finance bid of Technically Qualified bidders on 05.11.2021 at 3.30 PM.
