

RECOMMENDATION OF THE TENDER EVALUATION COMMITTEE (TEC) ON THE OPENING OF TENDER FOR AFLOAT REPAIR OF SL JAHANAVI FOR THE YEAR 2021-22

Online tender was published on IWAI website and e-procurement website on 07.10.2021 to receive online bids for repair of SL Jahanavi. The last date for online submission of bids was upto 03:00 PM on 18.11.2021 and opening of the tender was on 19.11.2021 at 03:30 PM. Following members of the committee has been nominated for opening and evaluation of the aforesaid tender.

- 1). Director I/C
- 2). Deputy Director (E).
- 3). Account Assistant/JAO.

After opening of the tender, it was found that the following bidders participated in the online tender and submitted their bids online by closing date and time.

- 1) M/s K B Vishal Enterprise, Patna
- 2) M/s Maa Vindhya wasni Enterprises, Patna
- 3) M/s Monisha Water Lines, Kolkata
- 4) M/s Dashrat Engineering, Patna.

As per credential submitted by the bidders and scrutiny by the committee the shortfall was noticed. So, committee recommended to ask the bidders to submit the shortfall documents. The last date for submission of shortfall documents was upto at 1300hrs on 06.12.2021. Accordingly, following bidders have been submitted their shortfall documents online by closing date and time.

- 1) M/s K B Vishal Enterprise, Patna
- 2) M/s Maa Vindhya wasni Enterprises, Patna
- 3) M/s Monisha Water Lines, Kolkata

Based on the credential submitted by the bidder, a comparative statement has been prepared and enclosed. As per comparative statement, it is found that the among four bidders M/s Maa Vindhya wasni Enterprises, Patna and M/s Monisha Water Lines, Kolkata has submitted all the requisite documents to qualify in technically. Whereas M/s K B Vishal Enterprises, Patna and M/s Dashrat Engineering, Patna has not submitted the requisite document as per prescribed in NIT. The TEC observed that the bid submitted by following bidder is technically qualified whereas M/s K B Vishal Enterprises, Patna and M/s Dashrat Engineering, Patna has not technically qualified:

- 1) M/s Maa Vindhya wasni Enterprises, Patna
- 2) M/s Monisha Water Lines, Kolkata

Therefore, the committee recommends opening the financial bid of technically qualified bidders i.e. M/s Maa Vindhya wasni Enterprises, Patna and M/s Monisha Water Lines, Kolkata.
