

SHORTFALL

TEC Recommendation for the tender Supply and deployment of Technical and other supporting manpower in IWAI -reg.

As per the NIT, the tender documents were to be submitted on line by the bidder to Director, IWAI, Kolkata on or before 20.11.2021 upto 18.00 hrs. and to be opened on 22.11.2021 at 15.30 hrs. Accordingly, the technical bids opened on 22.11.2021 at 15.30 hrs. After scrutiny of document submitted by above mentioned bidder, it is observed following

1. M/s Sarsp Tech Services Private Limited, 8 Ram Mandir Eastern Bazar, Ghalsrai, Chandauli, Uttar pradesh-232101 have not office either in Kolkata or Bhubaneswar.
2. M/s Udhas Nath Baba services Private Limited GT Road Alwalpur chowk near Ayani Mistri Palwal Faridabad Haryana 121106 have not office either in Kolkata or Bhubaneswar.
3. M/s Care Security and Allied Services, Plot No B13 2nd Floor Ruchika, Market Baramunda , Bhubaneswar , Odisha, 751003 have submitted all required documents to fulfil all technical parameter mentioned in the tender documents.
4. M/s Secura Infra Services Private Limited 4/18, Podder Nagar Kolkata West Bengal 700068 have submitted all required documents to full fill all technical parameter mentioned in the tender documents except EPFO challan. TEC opined to ask this document in short fall in online.
5. M/s Deshdut Infra Consultancy Private Limited Ram Rekha Sadan, SriRram Path, Saristabad, Gardanibag, Patna, Bihar, 800002 have not office either in Kolkata or Bhubaneswar.
6. M/s New Bengal Security Service, 85, MMC, block A, 2nd floor, K.N. Road, P.O. Berhampore, District. Murshidabad. West Bengal, 742101 have not office either in Kolkata or Bhubaneswar.
7. M/s Sumeet Security Service , Plot no- 1056/7 Bhubaneswar Orissa 751003 have submitted all required document except original tender documents signed by the authorised signatory.

From the above, It is observed by the TEC that at serial no.1,2, 5 & 6 the bidders have not office either in Bhubaneswar or at Kolkata. As per clause no.3.8 of ITB it is mentioned that the Bidder shall have a local office in the city of the Tender calling Authority or Awarding authority (R.O, IWAI, Kolkata) otherwise the bid will be rejected. Further, M/s Secura Infra Services Private Limited have not submitted EPFO challan for calculation of the no of manpower deployed by them and TEC optioned that we may ask this document in shortfall latest by 15:30 hrs on 26.11.2021. After receive the shortfall document TEC will finalised the Technical Bid.
