Recommendation:

During Preliminary Evaluation of Technical bids by approved TEC, it was found that some documents are missing as per checklist of eligibility criteria in the tender document. The bidders have been intimated to submit the missing documents on or before 01.02.2022. Accordingly, the bidders M/s. Reflection & M/s. Sign World submitted some documents before the allotted time. But, the bidder Sri. R. Saji Kumar has not been responded yet.

Final Evaluation of Technical Bid done by the TEC on 16.02.2022 and it is observed that, M/s. Sign World has not submitted Valid Solvency Certificate & M/s. Reflection has submitted a Bank Certificate from Punjab National Bank without any date / authorized signature.

Since, no bidders submitted all the required documents to fulfill the eligibility criteria as per tender document, the TEC recommends to cancel the same.

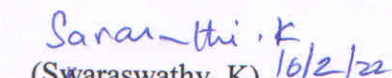
