The BG shall be valid for a period of 50 months i.e. up to 2 months beyond the expiry of the Contract Period of 48 months.

4. The performance Bank Guarantee as per para 3 above may also be submitted in the form of Omnibus BG in line with NHAI Policy circular no. 3.1.30/2021 dated 20.01.2021.
