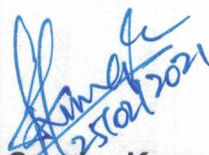
In continuation to the Technical Bid opening dated 05.02.2021, the Committee evaluated the Bids of all the Bidders' considered for evaluation.

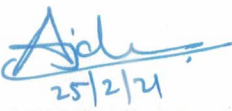
2. The Statement of evaluation is enclosed as **Annexure-I**. The summary of the evaluation is as follows:
