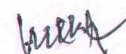
- i. M/s. K.R.Ravi, Tiruvarur

3. Further, the financial bids of the above responsive bidders were opened on 12.04.2021 @ 12.00Hr. The Composition of the Financial Evaluation Committee is the same as Technical Evaluation Committee. The aforesaid evaluation committee has evaluated the financial bids on 12.04.2021. The details of the financial bids are as detailed below:

4. After Evaluating the Financial bids, the committee found that the bid of M/s Dharani Hi-Tech Projects Private Limited, Mannargudi to Rs.4,19,501.67/- working out to 4.50 % above than the amount put to tender i.e. Rs.4,01,437.00/-is the lowest and Responsive bid.

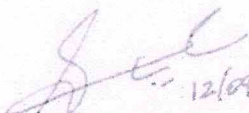

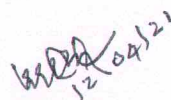
