Dear Sir,

This is with reference to the bids submitted on 24.05.2021 for the subject proposal. The results with respect to Technical Evaluation as approved by the Competent Authority is as under:

A. First Stage Technical Evaluation (Experience of the applicants in completed projects in last seven years):-

2.1 The Bidder M/s Applus India Private Limited in association with M/s Aaryan Infra Projects has failed to meet the minimum eligibility requirement - "minimum experience of Project Supervision/IC of 2/4/6- laning project of aggregate length equal to 165 km or more of similar category for which RFP is invited" as per clause 15 of 'Information to Consultants' section of the RFP. Hence, the bid of M/s Applus India Private Limited in association with M/s Aaryan Infra Projects has been declared Non-Responsive and not considered for second stage evaluation of technical proposals.

2.2 It was noted that the bidder M/s Geo Designs and Research Pvt. Ltd. in JV with Almonds Global Infra-Consultants Limited has claimed experience of Supervision for Construction of the project "Four laning of Vadodara-Dabhoi road SH-11 km 7.0 to km 31.0 and four laning of Vadodara-Savli road SH-158 falling under Vadodara district" vide completion certificate no. PB/2749 dated 01.06.2018 issued by Executive Engineer, District R&B Division, Vadodara executed in the period from June 2014 to June 2016. Moreover, the bidder has also claimed the experience of 'detailed engineering design' for four laning of the same roads and same chainage performed in the year 2016 vide and un-numbered an un-dated certificate.

Such design work done at the fag end of the construction period is not considered for DPR work. Accordingly, the work was not considered as eligible DPR experience

Hence, M/s Geo Designs and Research Pvt. Ltd., the lead member of the JV bidder M/s Geo Designs and Research Pvt. Ltd. in JV with Almonds Global Infra-Consultants Limited did not meet the 0.5 times (for lead member) the minimum eligibility requirement - "minimum experience of preparation of detailed Project Report/Feasibility

Study cum Preliminary Design Report of 2/4/6-laning project of aggregate length equal to 110 km or more of similar category” as per clause 15 of ‘Information to Consultants’ section of the RFP. Hence, the bid of M/s Geo Designs and Research Pvt. Ltd. in JV with Almonds Global Infra-Consultants Limited has been declared Non-Responsive and not considered for second stage evaluation of technical proposals

2.3 The bidder M/s LEA Associates South Asia Pvt. Ltd. vide their letter no. LASA/BD/ Proposal/NHAI/IE/Odisha/R-V/Pkg 1/71693/2021 dated 21.08.2021 had submitted their updated technical capacity before the financial opening of the Consultancy work “Independent Engineer for Supervision of Development of six lane access control of Raipur-Visakhapatnam Economic Corridor under Bharatmala Pariyojana from Design Chainage 124+611 Dhanara (Odisha/Chhattisgarh Border) to Design Chainage 249+000 Kaliagura in the state of Odisha on HAM Mode (Package-I)” The letter mentioned that the Technical Capacity of M/s LEA Associates South Asia Pvt. Ltd. is exhausted for this financial year. In this view, the bid of M/s LEA Associates South Asia Pvt. Ltd. has been declared **Non-Responsive** and not considered for second stage evaluation of technical proposals.
