3.1. The representations as received have been examined by the constituted Evaluation Committee and reply to the representation as approved by Competent Authority is enclosed at Annexure- I.

3.2 As per details provided by the bidder vide letter no. HEC/NHAI/IE/Raipur-Visakhapatnam/2021-22/1337 dated 25.08.2021 and Information available with NHAI, the Technical capacity of M/s Highway Engineering Consultants in Joint venture with M/s G-Eng Advisory services Private Limited was calculated considering 10(ten)

IE/AE/SC consultancy works of weightage **equivalent to 8.05 assignments** awarded to Highway Engineering Consultants in current Financial Year. Accordingly, the calculated technical capacity of the bidder came out to be (-1.90). As a result, the bidder has failed in Technical capacity and was declared as Non-Responsive and ineligible for opening of Financial Proposals.

3.3 The bidder **M/s K & J Projects Private Limited in Association with Upham International Corporation Private Limited** has updated their Updated Technical Capacity disclosing that they have been awarded new AE/IE/SC assignments; as a result, the Technical Capacity of the bidder has become negative **(-0.90)**. For the evaluation of Updated Technical Capacity, only those key professionals were considered who were disclosed by the bidder in their original technical proposal; any new key professionals were treated as new submission and have not been considered for evaluation of the Updated Technical Capacity. As a result, the bidder **M/s K & J Projects Private Limited in Association with Upham International Corporation Private Limited** has failed in Technical capacity and was declared as Non-Responsive and ineligible for opening of Financial Proposals.

3.4 In view of the representation submitted, the bidder, **M/s Geo Designs and Research Pvt. Ltd. in JV with Almonds Global Infra-Consultants Limited** has been considered Responsive. Accordingly, their bid has been evaluated as following:

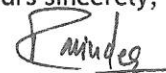
