2. M/s SA Infrastructure Consultants Pvt. Ltd. JV with M/s Technocrats Advisory Services Pvt. Ltd. in Association with M/s Upham international Corporation, vide email dated 13.10.2021 reported that the debarment of M/s Technocrats Advisory Services Pvt. Ltd. has been stayed by the Hon'ble High Court vide its order dated 08.09.2021 in the Writ petition (C) 9864/2021 & CM APPL. 30356/2021 (interim relief). Further, the bidder has also brought out that bid of M/s Technocrats Advisory Services Pvt. Ltd. has been considered responsive in many projects recently opened by MoRTH, been awarded PMC project of MoRTH and declared as H-1 in two projects of NHIDCL, on the basis of above order.

3. Evaluation Committee deliberated on the facts submitted by the bidder and noted that the debarment of M/s Technocrats Advisory Services Pvt. Ltd. as issued by MoRTH vide letter dated 26.08.2021 has been stayed by the Hon'ble High Court vide its order dated 08.09.2021 till next hearing date which is scheduled for 18.01.2022. Based on this order MoRTH itself has considered the bid of M/s Technocrats Advisory Services Pvt. Ltd. as technically responsive in its projects.

4. In view of above facts, the bid of M/s SA Infrastructure Consultants Pvt. Ltd. JV with M/s Technocrats Advisory Services Pvt. Ltd. in Association with M/s Upham international Corporation, has been considered as eligible for financial bid opening and the revised result of technical evaluation approved by Competent Authority is as under-
