The received bids were opened by the committee on schedule date and time at Regional Office, UP (East), Varanasi. The Technical bids of following bidders have been received till bid due -

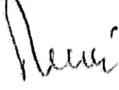

4. M/s Uma Associates, Varanasi

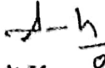
The above bids have been evaluated by the committee. During evaluation, this office vide letter dated 08.06.2021, (Flag A), sought some clarification in respect of bid of M/s UMA Associates. Bidder M/s UMA Associates, vide letter dated 08.06.2021, (Flag B) submitted their clarification and relevant documents, which was found in order. The evaluation sheet (Technical Bid) is Annexed herewith as Annex-1. Bids of all 04 bidders, namely M/s SRSC Infra Private Limited, Noida, M/s R.G. Buildwell Engineers Ltd., Ghaziabad, M/s Ganga Sagar Singh, Ghazipur & M/s Uma Associates, Varanasi, have been found technically responsive.

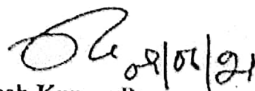
It is also submitted that, road stretches to be repaired under this bid are in very damaged condition and lots of difficulties are being faced by road users. In this connection, Civil Administration, District Azamgarh, has also requested to take up the repair work on priority. Therefore, it is also proposed to open the financial bid at the earliest.
