Sutreja & Co	Non-responsive	(1) The bid capacity calculated by M/s Sutreja & Co is based on value of works executed in F.Y.2014-15, however as per clause of 4.6 of ITB of RFP, the value of the work to be taken from last three F.Y. only. If the bid capacity is calculated based on value of work from last 3 F.Y. it comes out to be 1.26 which does not meet qualifying criteria. (2) Supporting Documents for required few key equipment's are not submitted as per clause 4.4 B (b)(i) of ITB. Therefore as per clause 4.8 & 26 of ITB of RFP the bidder M/s Sutreja & Co is non-responsive.

- The committee have found three bidders technically responsive; therefore, the Committee recommends for opening of financial bids on 09.07.2021 at 17.00 Hrs.
