2. You are requested to return a duplicate of the LoA as an acknowledgement and sign the Contract Agreement within the period prescribed in Clause 1.3 of the RFP.

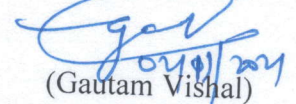
