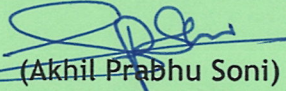

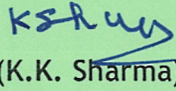

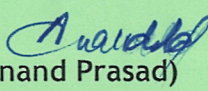
5. 01 no. Bidder have participated in the e-tender as listed below and submitted the Bid Cost & EMD in physical form (enclosed as per Annexure-II).

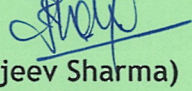
