

Minutes of the Meeting of Tender Evaluation Committee dated 17.08.2021 for the works of;

“Elimination of 3 Nos of Black Spots TN-(02)-224, TN-(02)-097 & TN-(02)-601 on Trichy - Madurai section of NH-38 (Old No. 45B) in the State of Tamil Nadu (2nd call)”

1. The subject tender for executing Blackspot works under 2nd call was invited & Technical Bids were opened on 09.08.2021 @ 11/00 Hrs. 1 No. of Bid was received through online. The Committee evaluated the single bid based on the available scanned copy.
2. Upon the evaluation, it is noticed that, M/s PR&Co., Madurai has not furnished the Litigation History in the prescribed format available in RFP. Also, missed to furnish Degree/Diploma certificate & Age proof for the proposed Key Personnels. Further, the Lease Agreement for one equipment (Air Compressor) has different name of Lessor in invoice.
3. However, as the subject Tender is for Second Call and single bid is received, the Committee recommended seeking clarification from the bidder duly considering that elimination of black spots is an urgent nature of work.
4. Also, the Committee recommends to obtain an Undertaking from the Bidder that during execution they engage machinery/Key Personnel as per the requisite criteria specified in the RFP provisions, to proceed further evaluation.
5. Consequent upon approval of Competent Authority, details were sought from the bidder and in turn, the bidder i.e. M/s PR and CO., Madurai has furnished compliances as under;

6. Also, the bidder has furnished an Undertaking stating that, during execution the machinery/Key Personnel as per the requisite criteria specified in the RFP provisions will be engaged in case of Contract is awarded to the bidder.
7. Based on the submission of Bid document, clarification along with undertaking, the Committee unanimously recommends to consider the bid submitted by M/s PR & Co., Madurai.
