The Bid Evaluation Committee has evaluated the Technical Bids of the above said Bidders in detail as per eligibility criteria of RFP with respect to the details furnished by the bidders. The details of Technical Evaluation are as per Annexure enclosed. Criteria

The technical bid evaluation results were examined by the Evaluation committee and the following observations were made:

1) A Balaramareddy.

The committee verified all the documents furnished by the bidder through e-portal system as per the requirement of RFP:

Findings of the Committee:-

- As per the RFP Section-II, Clause 4.4 B (b) (i) Page No. 11, mentioned Batch type hot Mix 100-120 TPH 1Nos. The bidder submitted DM-60 Drum Mix Plant (Own)
- As per the RFP Section-II, Clause 4.4 B (b) (i) Page No. 11, mentioned Sensor Paver finisher- 1nos .The bidder submitted mechanical Paver.
- The Bidder fulfilled remaining all the conditions mentioned in RFP(as above Table-1).

Decision of the Committee: The bidder not having the Batch type hot Mix 100-120 TPH. Hence technical bid evaluation Committee decided to consider the bid as "Non Responsive".

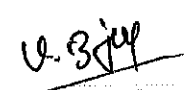
2) B.G. Arvind.

The committee verified all the documents furnished by the bidder through e-portal system as per the requirement of RFP.

Findings of the Committee:-

- As per the RFP Section-II, Clause 4.4 B (b) (i) Page No. 11, mentioned Batch type hot Mix 100-120 TPH 1Nos.The bidder submitted DM-60 Drum Mix Plant (Own).
- As per the RFP Section-II, Clause 4.4 B (b) (i) Page No. 11, mentioned Sensor Paver finisher- 1nos .The bidder submitted mechanical Paver.
- The Bidder fulfilled remaining all the conditions mentioned in RFP (as above Table-1).

Decision of the Committee: The bidder not having the Batch type hot Mix 100-120 TPH. Hence technical bid evaluation Committee decided to consider the bid as "Non Responsive".

3) M. Sanjeev Raju.

The committee verified all the documents furnished by the bidder through e-portal system as per the requirement of RFP:

Findings of the Committee:-

- Section-II, Clause 4.4 B (b) (i) Page No. 11 mentioned that, demonstrate key equipment's produced all necessary documents. The bidder submitted list of machinery submitted but supporting documents not submitted.
- Section-II, Clause 4.6, Page No. 11 mentioned that, the accessed Bid Capacity should be more than 492.40 Lakhs. The bidder accessed bid Capacity is 196.05 lakhs is less than required bid capacity.
- The Bidder fulfilled remaining all the conditions mentioned in RFP (as above Table-1).

Decision of the Committee: The bidder accessed bid Capacity is 196.05 lakhs is less than required bid capacity of Rs 492.40 Lakhs. Hence the technical bid evaluation Committee decided to consider the bid as "Non Responsive".

4) Arjunvaisnavi Infrastructure and Development Pvt Ltd

The committee verified all the documents furnished by the bidder through e-portal system as per the requirement of RFP:

Findings of the Committee:-

- As per the RFP Section-II, Clause 4.4 B (b) (i) Page No. 11, mentioned that, vibratory Road Roller 1 no and Pneumatic Tyred Roller 1 Nos. The bidder submitted only Hire agreement not submitted supporting document i.e invoice.
- Section-II, Clause 4.6, Page No. 11 mentioned that, the accessed Bid Capacity should be more than 492.40 Lakhs. The bidder accessed bid Capacity is 202.55 lakhs is less than required bid capacity.
- The Bidder fulfilled remaining all the conditions mentioned in RFP (as above Table-1).

Decision of the Committee: The bidder accessed bid Capacity is 202.55 lakhs is less than required bid capacity of Rs 492.40 Lakhs. Hence the technical bid evaluation Committee decided to consider the bid as "Non Responsive"

5) PR and Co Engineers and Contractors.

The committee verified all the documents furnished by the bidder through e-portal system as per the requirement of RFP:

Findings of the Committee:-

- As per the RFP Section-I, Clause 3 , Page No. 4, mentioned that, bidder should pay Rs 25,000/- Cost of bid document . The bidder submitted MSME UDYAM -TN-12-0006000 and Certificate No TN12A0055013 for fee exception. But MSME fee exempted only for Goods and services .
- The Bidder fulfilled remaining all the conditions mentioned in RFP (as above Table-1).

Decision of the Committee: Cost of bid document fee exempted only for Goods and services not for the works. Hence the technical bid evaluation Committee decided to consider the bid as “Non Responsive”.

6) S R Ballary

The committee verified all the documents furnished by the bidder through e-portal system as per the requirement of RFP:

Findings of the Committee:-

- As per the RFP Section-II, Clause 4.4 B (b) (i) Page No. 11, mentioned Batch type hot Mix 100-120 TPH 1Nos. The bidder submitted DM-60 Drum Mix Plant (Own)
- As per the RFP Section-II, Clause 4.4 B (b) (i) Page No. 11, mentioned Tandem roller-1Nos, Vibratory Roller-1Nos, Air compressor-1Nos, and Emulsion pressure Distributor-1Nos. The bidder submitted the invoices but the age of machinery is more than 5 years.
- The Bidder fulfilled remaining all the conditions mentioned in RFP (as above Table-1).

Decision of the Committee: The bidder not having the Batch type hot Mix 100-120 TPH. Hence technical bid evaluation Committee decided to consider the bid as “Non Responsive”.

Conclusion of Committee

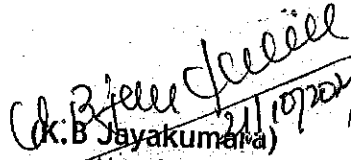
Based on the technical scrutiny of all the participated 6(six) bidders, it is noticed that none of the bidders satisfy the stipulated conditions of the RFP. For an instance as per the RFP mainly Clause no Section-II, 4.4B (b) (i) The machinery and equipment required for the work is not met by all the bidders and in respect of M/s. PR & CO Engineers, they have not submitted the bid documents cost quoting the reasons that they have the MSME registration.

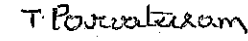
However, as per the Government of India Gazette Notification dated 23.03.2012, the exemption is limited only to goods and services and not for the work. Hence, this bidder is also considered as non-responsive.

In view of the above findings, the technical committee opined to go for short term tender (15 days) as per the NHAI Policy matter dated 02.08.2016, since the nature of work is of emergent nature and the stretch has developed many potholes.
