3. From the above table, it may be noticed that in all the three NITs vide No.10, 11 and 20, **M/s. Saadhya Infra Solutions LLP.** is the L1. Further, it is also observed that the amount quoted by M/s. Saadhya Infra Solutions LLP. is different in words and digits in financial Bid of NIT No.11 Annexure II, Form 7, Sl. No.(A). Therefore, the amount quoted in words (i.e. ninety two lakhs four thousand only) has been considered.

4. As per the NHAI Circular No.12.21/2020 dated 19.06.2020 of para 05 each team of two key personal Sr. Road Safety Auditor cum Team Leader and Traffic Planner shall not be eligible for award of more than **04** NHAI contract packages at any point of time.

5. **M/s. Saadhya Infra Solutions LLP.** vide email dated 11.11.2021, is having 02 (two) projects on hand and **M/s. Shweta Technophile Consultants Pvt. Ltd.** vide email dated 11.11.2021, is having 03 (three) projects on hand and brief details are as below:

6. Based on the above table **M/s. Saadhya Infra Solutions LLP.** would be awarded only 2 projects out of 3 NITs. Since, NIT No.11 being 7th Call and NIT No.20 being 6th call , The Committee decided to consider to issue LOA to to **M/s. Saadhya Infra Solutions LLP** for NIT No.11 & 20 and rebidding for NIT No.10 being 2nd call.

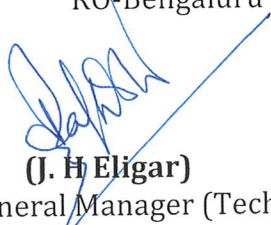

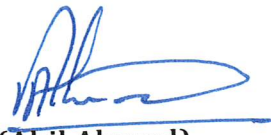

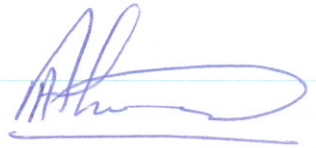
