The online tender was invited vide notification cited 2nd above as 6th Call with due date of submission of Technical bids on **02.09.2021**. Accordingly, the Constituted Bid Evaluation Committee has opened the Technical bids on the scheduled date of **03.09.2021** and in which it is noticed that the following Safety Consultants have submitted the Technical bids on the scheduled date.

1. M/s. Saadhya Infra Solutions LLP. Hyderabad
2. M/s. Shweta Technophile Consultants Pvt. Ltd. Ghaziabad (UP)
3. M/s. Nest Consultancy Services.

2. In the meanwhile, NHAI HQ vide letter cited 1st above, the 28 consultants having 32 teams are considered for empanelment as Safety Consultant (enclosed) and the empanelment of these 28 firms/32 teams will add to the existing list of 21 firms already empaneled as Safety Consultants vide NHAI Circular cited 3rd above.

3. As per the NHAI HQ Policy Guidelines cited 1st & 4th above and in which it is noticed that the Safety Consultants **M/s. Saadhya Infra Solutions LLP.** and **M/s. Shweta Technophile Consultants Pvt. Ltd.** are in the approved empanelment list and the each team of Safety Consultant is eligible to participate for 04 (four) NHAI contract packages. This empanelment shall remain valid for 05 (five) years.

4. As per the MORTH circular cited 3rd above, the 51 consultants having 65 teams have been empaneled as Road Safety Consultants and the **M/s. Nest Consultancy Services.** is in the approved empanelment list.

5. The Constituted Bid Evaluation Committee has evaluated the Technical bids of the above said Safety Consultants as per the details in the Technical bid in line with the RFP and the details of evaluation are as per Annexure-A, B & C and the brief details are as below:

As per the Policy No.12.21/2020 dated 19.06.2020 of para 05 each team of two key personal Sr. Road Safety Auditor cum Team Leader and Traffic Planner shall not be eligible for award of more than 04 NHAI contract packages at any point of time.

As per email dated 01.10.2021, **M/s. Saadhya Infra Solutions LLP.** is having 02 (two) projects on hand and **M/s. Shweta Technophile Consultants Pvt. Ltd.** is having 03 (three) projects on hand and **M/s. Nest Consultancy Services.** is having no projects on hand.

The issues of **M/s. Nest Consultancy Services.** has been deliberated by the committee and committee observed that **M/s. Nest Consultancy Services.** is empaneled by MORTH vide circular dated 01.07.2021. The team members as per MORTH circular are Team Leader, Road Safety Auditor and Road Safety apprentice. Whereas team members as per NHAI empaneled and requirement are Sr. Road Safety Auditor cum Team Leader and Traffic Planner. The Traffic Planner is not the part of team as approved by the empaneled of MORTH which is a critical requirement for Road Safety Auditor as per RFP.

Further, the team approved by MORTH **M/s. Nest Consultancy Services.** is different than the team proposed by **M/s. Nest Consultancy Services.** in the Bid.

As per RFP, Invitation of Proposal of Introduction of para 1 (iv) and it states that NHAI had invited applications from the interested firms for empanelment as safety consultant for providing consultancy to the project highway in accordance with the safety requirement set forth in the Schedules mentioned above. Only those consultants who have been empanelled by NHAI are eligible to submit their financial proposal and work shall be awarded on least cost basis. The list of empanelled consultants are listed in Appendix IV.

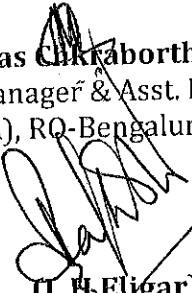

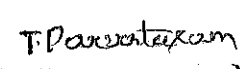
Considering the above, the committee decided that **M/s. Nest Consultancy Services.** may be declared as Non Responsive.
