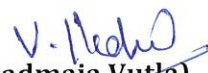

As per the details furnished by the bidders, **1) M/s. Pr and Co.** not submitted the Bid Document Fee and **1) Sh. M Sanjeeva Raju.** the available Bid capacity is **1.786 Cr.** < the total bid value but as per Section-II vide clause 4.6 of RFP, Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity is more than the total bid value and hence the Bid Evaluation Committee considered these 02 (two) bidders as Technically Non Responsive.

In view of the above, out of 04 (four) bidders only 02 (two) bidders namely **1) M/s. Arjunvaishnavi Infrastructure & Developers Pvt. Ltd.** and **2) M/s. Jaihind Road Builders.** are considered Technically Responsive and hence the Bid Evaluation Committee recommends to open the Financial bids of the Responsive bidders by duly getting the approval of the Competent Authority.

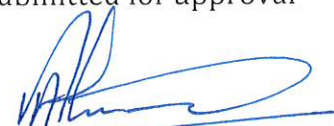
