In continuation to Evaluation Committee MOM dated 01.12.202, the Financial Bid was opened on 06.12.2021 for following Bidders

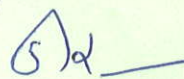
- 1) Scientific Security Management Services Pvt. Ltd.
- 2) Eagle Security and Personal Services
- 3) Aroon Aviation Services Pvt. Ltd
- 4) ShriKrupa Services Private Limited.
- 5) Yashodhara Mahila Audyogik Sahakari Sanstha Maryadit

The evaluation Committee results for financial evaluation are attached as Annexure - III. It is observed that, M/s. Aroon Aviation Services Pvt. Ltd, send a letter Dt. 15.12.2021, where he claim that, he was obtain highest score of Marks (including Technical and Financial Bid), wherein calculation are consider on Estimated Value + Service Charges. As per clause 4.2.2 Evaluation of Financial Bid and Clause 4.2.3 Illustrations whereas calculation are consider on Quoted Price i.e. Percentage of Service Charge. The same was conveyed vide NHAI RO Mumbai letter No. NHAI/RO/Mum/F&A/Admn/2021/1595 Dt. 04.01.2022 to M/s. Aroon Aviation Services Pvt. Ltd. The committee felt that calculations submitted by M/s. Aroon Aviation Services Pvt. Ltd are not in accordance with RPF conditions.

The H1 Bidder, M/s Yashodhara Mahila Audyogik Sahakari Sanstha Maryadit, who got maximum mark, (including Technical and Financial Bid), quoted 0.01% Service / Agency Charge, (i.e. Rs. 12,683.48 Agency charge on estimated value Rs. 12,68,34,816/-). In the view of Evaluation Committee, the Service / Agency Charges quoted by the H1 Bidder Rs. 12,683.48 is very less and not workable so that, the justification letter vide ref. no. 03 and 04 was send by RO Mumbai office. The H1 bidder is failed to justify the same and just communicated acceptance of term and condition.

Considering above fact and to avoid legal complications the evaluation Committee recommended rebidding of tender through GEM portal for approval of the Competent Authority.

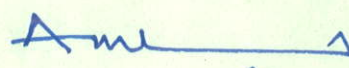
