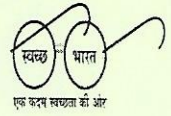

(2/3) M/s Jawala Travels

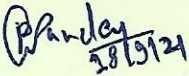

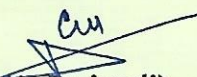
