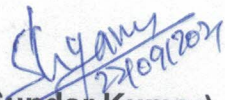

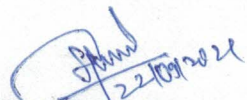

In continuation to the opening of Technical Bids for the subjected work, the Committee evaluated all the Bids as per criteria mentioned in the Bid Document.

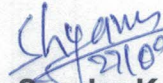
