महोदय,

This has reference to above and your proposal submitted for the subject consultancy project.

2. The National Highways Authority of India has accepted your proposal at the quoted contract amount of **Rs. 5,75,10,000/- (Rs. Five Crore Seventy five Lakhs Ten Thousand only)** which may be revised later(if required) after compliance of policy circular dated 15.11.2021 (interview of Key Personnel). The above contract price is inclusive of all taxes (except Goods and Services Tax), duties, fees, levies and other imposition as may be levies under the applicable law and NHA shall deduct taxes as applicable, out of the eligible payments to be made to the Consultant. The amount towards Goods and Service Tax shall be paid by NHA separately on reimbursement basis, after submission of proof of depositing the same with the concerned authorities by the consultant.

3. It is requested to furnish within 15 days of issue of this Letter of Award (LoA) an unconditional Bank Guarantee from a Nationalized Bank as per details mentioned in Section-2, Clause 7 of RFP for an amount equivalent to 3% of the Total Contract Value i.e. **Rs. 17,25,300/- (Rupees Seventeen Lakhs Twenty Five Thousand Three Hundred Only)** towards Performance Security. This Performance Security shall be valid for a period of 50 months i.e. up to 2 months beyond the expiry of the Contract period.

4. Upon submission of the required Performance Security and completion of interviews of key personnels proposed for the consultancy assignment as per NHA Policy Circular no. 10.1.36 dated 26.09.2023, you are required to sign the Contract Agreement with NHA. Thereafter, the services shall commence as per Contract Provisions.

5. You are requested to submit acceptance of this LoA with 7 (seven) days of from issue of this LoA.
