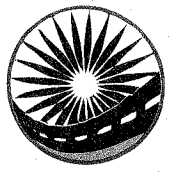

With reference to your bid on subject cited above, it is to convey that your proposal for hiring of one number Commercial Vehicles Innova/Equivalent on monthly basis at the monthly rate of Rs. 80,000/- (Eighty Thousand Only) for travel up to 3500 Kms and Rs. 14 (Fourteen Rupees only) per km for extra km over 3500 Kms in a month and two number Commercial Vehicles Bolero/Scorpio/Equivalent on monthly basis at the monthly rate of Rs. 55,000/- (Fifty Thousand Only) for travel up to 3000 Kms and Rs. 12 (Twelve Rupees only) per km for extra km over 3000 Kms in a month for PIU-Ahmedabad for 02 years has been accepted by Competent Authority.

2. The above financial quote is inclusive of all taxes, duties, fees, levies and other imposition as may be levied under the applicable law and NHA shall deduct taxes as applicable, out of the eligible payments to be made to the Consultant.

3. The amount towards GST shall be paid by NHA separately on reimbursement basis, after submission of proof of depositing the same with the concerned authorities.

4. You are requested for the following:

- (i) To confirm your acceptance of this Letter of Acceptance (LoA).
- (ii) To submit performance Security amount of Rs. 1,50,000/- (Rs.50,000 for each of the 03 vehicles) in the form of DD in the name of National Highways Authority of India payable at Ahmedabad within 10 days from the receipt of this Letter of Acceptance.
- (iii) To submit the following documents:
 - (a) Comprehensive Accident and workman Compensatory insurance policy coverage in respect of every employee employed by agency and third-party liability as per rule which shall be valid for entire period of the contract.
 - (b) Registration under GST Act/PF code/commercial tax, etc.
 - (c) Copy of RC Book (as per conditions mentioned elsewhere in bid document)

- (d) Registration, taxi passing and other vehicle related document /paper of the vehicles.
- (e) Copy of Driver's Driving License
- (f) Copy of PAN Card
