3.1 As per Annexure-B of RFP and clause 4 of RFP, the Technical Eligibility criteria comprises of (i) Experience of at least 1 year of similar work with satisfactorily performance (ii) Ownership/Lease of at least 2 vehicles.

3.2 Both the bidders satisfy the criteria of Ownership/Lease of at least 2 vehicles and experience of at least 01-year experience.

4. After detailed deliberation, the evaluation committee declared M/s P H Patel - HUF and M/s Khodiyar Tour and Travels as technically qualified and responsible and recommended to open the financial bid of both bidders subject to approval from competent authority.
