With reference to subject cited above, it is brought to notice to the committee that the RHS Service Road of Mubarakpur VUP from Km 323+410 to 323+760 has been completely damaged due to heavy traffic moving from Kurana to Bhopal Bypass. On observation of non-compliance of the contractor this office vide tender under reference (iii) has invited the repair work at the risk and cost of the contractor and vide letter under reference (iv) dated 10.09.2021 has notified the contractor that it is a default of the maintenance obligation of the contractor and action as per Clause 14.7 and 14.9 is being initiated by this office for which 20% as damages shall be recovered in addition to the estimated cost of works for execution of the works in exercise of Authority's Right to Take Remedial Measures and Overriding powers of the Authority.

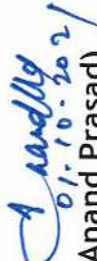

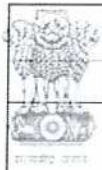
