Sub: Construction of Single Flyover on LHS at Narasapura @ Ch: 41+774 (KA-02-231) under road safety for rectification of Blackspots in the stretch of Bangalore-Hoskote-Mulbagal Section of NH-75 (old No.NH-4) from Km.237.700 to Km 318 in the State of Karnataka under EPC mode- Reg.

As per the recommendations of Bid Evaluation Committee vide Technical Minutes dated 15.03.2022, Competent Authority vide letter No.4775 dated 15.03.2022, has accorded approval for opening of the Financial bids of 04 (four) technically responsive bidders. Accordingly the Bid Evaluation Committee has opened the Financial Bids on 16.03.2022.

In this context, the Financial proposals submitted by the bidders have been forwarded to financial consultants vide this office email dated 16.03.2022 and in response, financial consultants has submitted financial bid evaluation report for the subject project vide email dated 21.03.2022. The details of Financial proposals are as below:

As per Cl. no. 3.3.1, Section-3 of RFP, the evaluation committee noted that **M/s. SVS Mookambika Construction Private Limited.** has quoted the lowest price i.e. **Rs.15,39,61,164/-** excluding GST at 12% and therefore declares the said bidder as **"Selected Bidder"**.

As per Section-II vide clause 2.21.1 of RFP, the selected bidder shall furnish to the Authority an irrevocable and unconditional guarantee from a Bank in the form set forth in Appendix-VII (the "Performance Security") for an amount equal to **03% (three percent)** of its Bid Price i.e. **Rs.46,18,835/-** within 30 (thirty) days of receipt of Letter of Acceptance.

As per NHAI HQ Policy Circular No. 1.1.31/2019 dated 19.12.2019, Para 6.2, Regional Officer shall devise mitigation measures following provisions of para-5, approve the estimate, carry out necessary procurement and execute the works costing upto **Rs.50 Cr.** (including the cost of land acquisition) for each black spot including all centages, on COS/Standalone basis.

As per the above said NHAI Policy Circular, the Bid Evaluation Committee recommends for issue of LOA to the L1 bidder **M/s. SVS Mookambika Construction Private Limited.** for the quoted amount of **Rs.15,39,61,164/-** excluding GST at 12% which is **below 18.60%** on the amount put to tender of **Rs.18,91,41,481/-** excluding GST at 12% and also recommends for obtaining the undertaking from the selected bidder for executing the subject work with the quoted amount as per the Conditions of Contract, by duly obtaining the approval of the Competent Authority.
