4. In case of failure of submission of Performance Security within the additional 60 (Sixty) days time period, the award shall be deemed to be cancelled by the Authority as per Clause 2.21 of the RFP.

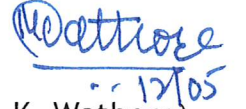

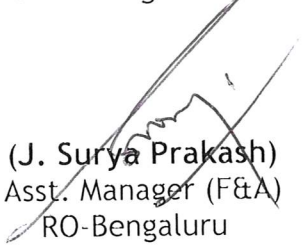

As per Section-II vide clause 2.21.1 of RFP, the selected bidder shall furnish to the Authority an irrevocable and unconditional guarantee from a Bank in the form set forth in Appendix-VII (the "Performance Security") for an amount equal to 03% (three percent) of its Bid Price i.e. Rs.63,87,245/- within 30 (thirty) days of receipt of Letter of Acceptance.

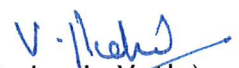
As per NHAI HQ Policy Circular No. 1.1.31/2019 dated 19.12.2019, Para 6.2, Regional Officer shall devise mitigation measures following provisions of para-5, approve the estimate, carry out necessary procurement and execute the works costing upto Rs.50 Cr. (including the cost of land acquisition) for each black spot including all centages, on COS/Standalone basis.

As per the above said NHAI Policy Circular, the Bid Evaluation Committee recommends for issue of LOA to the L1 bidder M/s. **The Trinity Group**. for the quoted amount of Rs.21,29,08,168/- excluding GST at 12% which is below 13.00% on the amount put to tender of Rs.24,47,22,033/- excluding GST at 12% and also recommends for obtaining the undertaking from the selected bidder for executing the subject work with the quoted amount as per the Conditions of Contract, by duly obtaining the approval of the Competent Authority.

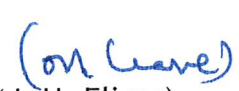
