- Statutory deduction will be made as per prevailing rules from bill. However, if any tax deduction remains un-noticed it will be entire responsibility and liability of the agency viz. M/s Abdul Muttallib.
- This work order is initially for a period of One year only. However, services may be continued beyond one year period on the above conditions if required by NHAI for further period as decided by NHAI. It is also to be noted that any individual vehicle may be demobilized at any time during the tenure period on account of unsatisfactory services while serving one month notice.
