Further, as per RFP documents, you are required to promote and incorporate a Special Purpose Vehicle solely for the purpose of implementing the project (the "Concessionaire") as a Limited Liability company under Companies Act 2013, as the entity which shall undertake and perform the obligations and exercise the rights of the Selected Bidder under the LOA, including the obligation to enter into the Concession Agreement pursuant to the LOA for undertaking the Project pursuant to Recital (E) of Draft Concession Agreement.

4. The Concessionaire shall, for the performance of its obligations under the Concession Agreement, provide to the Authority no later than 30 (thirty) days from the date of the Agreement, an irrevocable and unconditional guarantee from a Bank for an amount of Rs. 11.70 Cr (Rupees eleven crore and seventy lakh only) equivalent to 3 (three) percent of Bid
