Sub: Construction of LVUP at Chikkanahalli at grade Junction Ch.111+000 (KA-02-221) under road safety for rectification of BLAck spot in the stretch of Tumkur-Chitradurga section from Km 75+00 to 189+000 of NH-48 (Old NH-4) in the state of Karnataka under EPC mode- **Hosting of final outcome of Technical Evaluation of bids & Disposal of objections** - reg.

Sir,

The bids were received (online) for the subject work on 23.12.2021 till 1100 Hrs. Bids were opened on 24.12.2021 at Regional Office, Bengaluru. The replies were sought from the non-responsive bidders by giving 03 days of time period to respond in case of any objection. The objections submitted by the bidders have been examined by the Evaluation Committee and final outcome is as detailed below;

Note-1: Arjunvaishnavi Infrastructure & Developers Pvt. Ltd.: Not eligible for next stage of Bidding, as the Bidder is not meeting the following minimum eligibility criteria:

- All the Projects as claimed by the Bidder in support of its Technical Capacity are not covered under any Category as specified in RFP by virtue of Clause 2.2.2.5(iii)(II) of RFP, as a result of which the Bidder fails to meet the minimum eligibility criteria specified in clause 2.2.2.2 (i) of RFP of having Threshold Technical Capacity of Rs. 14.05 Crore and clause 2.2.2.2 (ii) of RFP of having one similar works of 20% of EPC i.e. Rs. 3.75 Crore completed in last five financial years.
- In the absence of the Certificates in support of value of all existing commitments works for which Appointed Date/ Commencement Date has been declared and on-going works issued by the Client or its Engineer-in-charge not below the rank of Executive Engineer, we cannot assess the value of Bid Capacity. Therefore, in view of the Bidder fails to meet the minimum eligibility criteria of Assessed Available Bid Capacity specified in Clause 2.2.2.1 of RFP.

In addition to above, there are certain observations, which have not been complied by the Bidder. (Refer table above where we have submitted provided our point wise response to the representation).

Note-2: Ayyamar Infraprojects India Private Limited: The Bidder is declared as Not eligible for opening of Financial Bid, as the Bid submitted by the Bidder may be declared as Non-responsive on the following reasons:

- Bidder has not submitted any response to the clarification sought. Accordingly in view of non-submission of replies, the Bid submitted by the Bidder may be declared as non-responsive in accordance with Clause 3.1.5 of RFP, the relevant extract of which are furnished below-

If a Bidder does not provide clarifications sought under Clause 3.1.4 above within the prescribed time, its Bid may be liable to be rejected. In case the Bid is not rejected, the Authority may proceed to evaluate the Bid by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of the Authority.

- Since, the Bidder has claimed the Net Worth as on 31.03.2020 instead of 31.03.2021 and has not submitted any response to the clarifications sought, therefore, in the absence of available documents, the Bidder fails to meet the minimum eligibility criteria specified in Clause 2.2.2.3 of RFP. Therefore, in view of the above, the Bidder fails to meet the minimum eligibility criteria as specified in Clause 2.2.2.3 of RFP and further, as per Clause 3.1.5 of RFP, the said Bidder is declared as ineligible for opening of Financial Bid.

Note-3: BHR Constructions: Not eligible for next stage of Bidding, as the Bidder is not meeting the following minimum eligibility criteria:

- As per the Undertaking dated 15.02.2022, w.r.t. the fact that annual accounts for the latest financial year i.e. 2020-21 are not yet audited as on Bid Due Date, it is presumed that, M/s V. Raghavendra, Chartered Accountants are auditing the Books of Accounts of the Bidder for the FY 2020-21.

However, the certificate w.r.t. Annex-III, Annex-IV and Annex-VI submitted in the Bid were issued by NCS & Co., Chartered Accountants, while the contention of the Bidder is well taken that CA Raghuram Kamath who was auditing the Books of Accounts of BHR Constructions, died due to COVID-19 on 06.05.2021. However, in that case certificates

would have been issued by V. Raghavendra, Chartered Accountant, who is auditing the books of accounts for FY 2020-21.

Since, the certificates have been issued by a third party i.e. NCS & Co., Chartered Accountants instead of the Chartered Accountant auditing the books of accounts of the Bidder, hence, the same may not be considered. **Therefore, the Bidder is declared as Non-responsive as per Clause 3.1.6.1 read along with Clause 2.2.2.9 (i) and (ii) of RFP and in the absence of Annex-VI duly certified by the Chartered Accountant auditing the books of accounts, the Bidder also fails to meet the minimum eligibility criteria specified in Clause 2.2.2.1 of RFP.**

Further, in the absence of UDIN on the Undertaking w.r.t. the fact that the annual accounts for the latest financial year i.e. 2020-21 are not yet audited as on Bid Due Date and in the absence of Audited Financial Statements of FY 2020-21, the Net Worth as on 31.03.2020 may not be considered.

- In view of the above, the Bidder fails to meet the minimum eligibility criteria specified in Clause 2.2.2.1 and 2.2.2.3 (i) of RFP.

In addition to above, there are certain observations, which have not been complied by the Bidder (Refer Annexure-4 of our Report dated 12th March 2022).

Note-4: R. P. Projects Pvt. Ltd.: Not eligible for next stage of Bidding, as the Bidder is not meeting the following minimum eligibility criteria:

- In the absence of any supporting documents substantiating the nature of project i.e. whether the said project are covered under any Category specified in the RFP or not. Therefore, as a result of which the Bidder is not meeting the minimum eligibility criteria specified in Clause 2.2.2.2 (i) of RFP.

Note-5: S L V Constructions: Not eligible for next stage of Bidding, as the Bidder is not meeting the following minimum eligibility criteria:

- In the absence of any supporting documents substantiating the fact that whether M/s Jagannath H R & Co., Chartered Accountants is the Auditor of the Bidder who audits the annual books of accounts. Therefore, it cannot be established that whether the certificates issued w.r.t. Annex-III, Annex-IV and Annex-VI have been issued by the Chartered Accountants auditing the Books of Accounts. Therefore, the Bidder is declared as Non-responsive as per Clause 3.1.6.1 read along with Clause 2.2.2.9 (ii) of RFP. Further, the Bidder also fails to meet the minimum eligibility criteria specified in Clause 2.2.2.1 of RFP.
- Since, the Bidder has submitted the Provisional Financial Statements for the FY 2019-20 and FY 2020-21, therefore, we are neither able to assess the Net Worth as on 31.03.2021 nor we are able to assess the Net Worth as on 31.03.2020. Therefore, the Bidder fails to meet the minimum eligibility criteria specified in Clause 2.2.2.3 (i) of RFP.

Note-6: Vijay Kumar Sahu Infrastructure Pvt. Ltd.: Not eligible for next stage of Bidding, as the Bidder is not meeting the following minimum eligibility criteria:

- In the absence of UDIN on the certificate and also the discrepancies as pointed out in the clarifications sought, the certificate w.r.t. Value of B as per format as revised vide Corrigendum-2 dated 15.12.2021 duly certified by the Statutory Auditor, the Bidder fails to meet the minimum eligibility criteria of Assessed Available Bid Capacity, specified in Clause 2.2.2.1 of RFP.
- On the basis of available documents, it is not clear whether the audit of Financial Year 2020-21 is not completed as on Bid Due Date. Accordingly, in the absence of Audited Financial Statements of FY 2020-21, the assessment of Net Worth of the Bidder, which is required at the close of preceding financial year i.e. FY 2020-21 as per clause 2.2.2.3(i) is not possible. Therefore, in view of the above, the Bidder fails to meet the

eligibility criteria of having minimum Net Worth (the "Financial Capacity") of Rs. 94.00 lakh (Rs. ninety four lakh only) at the close of the preceding financial year which is required as per clause 2.2.2.3 (i) of RFP.

- In addition to above, there are certain observations, which have not been complied by the Bidder (Refer Annexure-4 of our Report dated 12th March 2022).

2. In view of the above, financial bids of the 08 Nos. of Technically responsive bidders (as mentioned in Table above) will be opened on **26.04.2022** at 15:00 Hrs, if possible.
