This Bank Guarantee shall be as per relevant format given in the RFP. This Performance Security shall be valid for a period of three years beyond the date of completion of services.

6. Upon submission of required Performance security, you are also required to sign the Contract Agreement as per Clause-9 of Letter of Invitation of RFP.
