6. Accordingly, the committee has evaluated the 6 Nos of Quotations on 15.12.2021 based on available scanned copies and the detailed

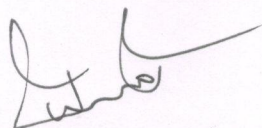





technical evaluation is furnished vide Annexure-A. Summary of the same is submitted as follows.

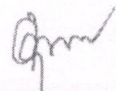

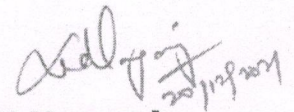
