With Reference to NHAI's Request for Proposal for "Development of 6-lane Access Controlled Greenfield Highway from Km. 97.000 to Km 162.500 Maradgi S Andola to Baswantpur section of NH-150C (Package-III of Akkalkot - KNT/TS Border) on HAM Mode under Bharatmala Pariyojana" and considering your proposal in this regard submitted on 17.02.2022 vide reference no. (i), NHAI hereby accepts your proposal at Bid price of Rs. **1416.41 Cr. (Rupees One Thousand Four Hundred Sixteen Crore and Forty One Lakhs only)** (Bid Project Cost of Rs. 1589.00 crore and first year O&M of Rs. 9.00 lakhs) as included in Appendix- 1B of your document and declares you as the "Selected Bidder" as per the provisions of RFP Documents.

2. The Concessionaire for due and faithful performance of its obligations during the Concession Period shall furnish a Performance Security by way of irrecoverable and unconditional Bank guarantee amounting to **Rs. 47.67 Crore (Rupees Forty Seven Crore and Sixty Seven Lakhs only)** i.e. 3% of Bid Project Cost within a period of the 30 days from the date of signing of the Concession Agreement. This LOA is being issued subject to final orders of the Hon'ble Delhi High Court in WP(C) 15460/2022.

4. You are required to comply with all the terms and conditions set forth in the RFP documents and subsequent addendums/ corrigendum issued. In case of any default on your part, you shall be liable for action as stated in the RFP Document.
