Dear Sir,

With Reference to NHA's Request for Proposal for "Development of 6-lane Access Controlled Greenfield Highways from Km 162.500 to Km 203.100 Baswantpur to Singnodi section of NH-150C (Package-IV of Akkalkot-KNT/TS Border) on HAM Mode under Bharatmala Pariyojna" and considering your proposal in this regard submitted on 17.02.2022 vide reference no. (i), NHA hereby accepts your proposal at Bid price of **Rs. 987.68 Crore (Rupees nine hundred eighty seven crore and sixty eight lakh only)** (Bid Project Cost of Rs. 1079.00 crore and first year O&M of Rs. 2.74 Crore) as included in Appendix-1B of your document and declares you as the "Selected Bidder" as per the provisions of RFP Documents.

2. In accordance with the clause 3.8.4 of the RFP document, you are requested to sign the duplicate copy of the LOA and return the same as your acknowledgement within 7 (Seven) days of the receipt of the LOA. Thereafter you are required to execute the concession Agreement within 45 (Forty five) days from the date of issue of LOA as specified in Clause 1.3 of RFP.

3. Further, As per RFP document, you are required to incorporate a Special Purpose Vehicle solely for the purpose of domiciling the project (the "Concessionaire"). The Concessionaire for due and faithful performance of its obligations during the Concession Period shall furnish a Performance Security by way of irrecoverable and unconditional Bank guarantee amounting to **Rs. 32,37,00,000/- (Rupees thirty two crore and thirty seven lakh only)** i.e. 3% of Bid Project Cost within a period of the 30 days from the date of signing of the Concession Agreement. Till the time the Concessionaire provides NHA with the performance Security the Bid Security shall remain in full Force and Effect (refer Clause 4.1.2 and Article 9 of DCA).

4. You are required to comply with all the terms and conditions set forth in the RFP documents and subsequent addendums/ corrigendum issued. In case of any default on your part, you shall be liable for action as stated in the RFP Document.
