This is to notify you that your Bid for execution of the project of "Four laning of Vadugapatti-Therkuvenganallur section from Km. 36/000 to Km.71/600 of NH-744 under Bharatmala Pariyojana in the state of Tamil Nadu on EPC Mode", at your quoted bid price amounting to Rs.723,33,00,000/- (Rupees Seven Hundred Twenty Three Crore and Thirty Three Lakh only) has been determined to be lowest evaluated bid and is substantially responsive and has been accepted.

You are also requested to furnish performance Security for an amount of Rs.21,69,99,000/- (Rupees Twenty One Crore Sixty Nine Lakh and Ninety Nine Thousand only) and additional performance security of Rs.9,05,76,000/- (Rupees Nine Crore Five Lakh and Seventy Six Thousand only) as per Clause 2.21 of the RFP within 30 (Thirty) days of receipt of this Letter of Acceptance (LOA). In case of delay in submission of Performance Security you may seek Extension of Time for a period not exceeding 60 (sixty) days on payment of Damages in accordance with Clause 2.21 of RFP.

3. In case of failure of submission of Performance Security and Additional Performance Security against Damages (if any) within the additional 60 (sixty) days, time period, the award shall be deemed to be cancelled/withdraw and bidder will be suspended for participation in the tendering process for the work of MoRTH/NHAI/NHIDCL and works under other Centrally Sponsored Schemes for period of One Year from the bid due date of this work by the Authority.

4. It may be noted that the execution of Contract Agreement for the subject project is expected by June, 2022 subsequent to considerable development in Land acquisition and the bid Security is to be kept valid till such date. The Bid Security shall be returned, without any interest, upon signing the Contract Agreement and furnishing Performance Security and Additional Performance Security in accordance with Clause 2.20.3 of the RFP.

5. If above conditions are acceptable to you, you are requested to return the signed duplicate copy of LOA as an acknowledgement within 7 days of issuance of LOA.
