- (iv) The Concessionaire shall, for the performance of its obligations during the Construction Period, provide to the Authority no later than 180 (one hundred and eighty) days from the date of this Agreement, an irrevocable and unconditional guarantee from a Bank for a sum equivalent to Rs.10,49,31,787/- (INR Ten Crore Forty
