Opening & Evaluation of Technical e-Bids for the work of Appointment of Safety Consultants for Six Laning of National Corridor NH-19 from Panagarh to Palsit from km 521.120 to km 588.870 (total design length 67.750 km) in the state of West Bengal under Bharatmala Pariyojna on BOT (Toll) basis

Introduction:-

In accordance with NHAI Policy Circular NHAI/Policy Guidelines/Road Safety Cell/2020 Policy No 12.21/2020 dated 19 June 2020 and as per request of PD, PIU-Durgapur, CGM (Tech)/RO had requested PD, PIU-Durgapur to submit draft RFP for engagement of Safety Consultants for Six Laning of National Corridor NH-19 from Panagarh to Palsit from km 521.120 to km 588.870 (total design length 67.750 km) in the state of West Bengal under Bharatmala Pariyojna on BOT (Toll) basis.

Accordingly, PD, PIU-Durgapur had submitted draft RFP to RO-Kolkata for the work of Appointment of Safety Consultants for Six Laning of National Corridor NH-19 from Panagarh to Palsit from km 521.120 to km 588.870 (total design length 67.750 km) in the state of West Bengal under Bharatmala Pariyojna on BOT (Toll) basis.

Accordingly, Detailed RFP was published on the Government e-procurement System i.e. <https://etenders.gov.in> as well as on NHAI website i.e. www.nhai.org on 21 Dec 2021.

The last date of submission of e-bids was scheduled on 11 Jan 2022. Accordingly, the technical e-bids were opened on scheduled date & time i.e. on 12 Jan 2022 at 15.00 Hrs in the office of the CGM (T) / RO-Kolkata by the Committee members.

No Authorised representative was present at the time of opening of Technical e-bids.

After opening of e-bids through Government e-procurement System i.e. <https://etenders.gov.in>, the Committee observed that, total 5 (five) nos of bids of the following firms were uploaded in e-portal:

All the above mentioned 05 nos firms are empanelled as per latest NHAI empanelment list. Also the Key personnel proposed for the subject safety consultancy works are matches with the personnel mentioned in the above empanelment list.

Documents uploaded by all the above mentioned 05 (five) nos Consultants in the e-portal regarding Technical qualification were verified and tabulated in the **Technical Evaluation Statement** which is attached herewith as **Annexure-A**.

In view of the above and after scrutinizing the documents uploaded by the above firms, the Committee unanimously decided to declare the e-bids of all the participated 05 nos firms technically responsive, hence recommends to open financial e-bids of both the firms in an convenient date, subject to approval of the Competent Authority.
