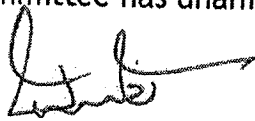

The opening of technical bids held on 05.01.2022 @ 15:00 Hrs and received 2 Nos. of bids from the following two bidders:

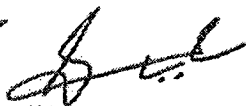
- i. RAMAN DIP SINGH, DELHI

2. The bids received through online are decrypted and evaluated as per qualification criteria set forth in RFP documents by the committee on 05.01.2022 and the technical bids of the said two bidders were examined and found that the bidder Shri RAMAN DIP SINGH has not furnished the documents in-accordance with Clause 7.1.11 Curriculum vitae with copy of qualification and experience certificates of the professionals to be engaged and deemed to be disqualified in Technical bid.

3. Even though Shri V.R.PALANIAPPAN was found eligible in Technical bid and there is no competitive bidder for opening of financial bid. In view of the above, the tender committee has unanimously decided to cancel this tender and invite 2nd call of NIQ.

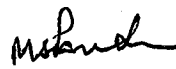
